- The sealed quotations shall be submitted and addressed to the **Member Secretary, Odisha Biodiversity Board, Regional Plant Resource Center Campus, Nayapalli, Bhubaneswar751015**.
- The offers received shall **remain valid for 60 days** from the date of tender opening.
