**TENDER CALL FOR PARKING SPACE**

The Regional Plant Resource Centre, Ekamrakanan, Nayapalli, Bhubaneswar intends to let out on rent to interested parties about 10,500sq.ft. cement; concrete parking space in front of main gate of the Botanic Gardens (Ekamrakanan), RPRC, Bhubaneswar/ interested parties may apply in the prescribed formats by 26<sup>th</sup> December, 2016 (4.00 PM) by registered/ speed post only. No hand delivery shall be entertained.

**PARKING SPACE**

1. Details of space:

Cement: concrete open floor space measuring 10,500 sq.ft. (approx.) in front of the Ticket Counter close to the main gate of the Botanic Garden of RPRC, Bhubaneswar suitable for parking of scooters, motor cycles, mopeds, cycles & 4-wheelers (LMV) with 6.0 ft. tall M.S. grills on three sides and partitioning by toe walls. Intending tenderers may inspect the parking site and available facilities before participating in the tender.

2. Scope of the Lease

- 2.1 The parking fees are prescribed @Rs.20/- per two wheelers per 6 hr. interval per day, @Rs.30/- per 3-wheeler/@ Rs40/-per 4-wheeler 6hrs per day. Priority will be given for two wheeler parking cannot be altered / changed/ enhanced without the approval of RPRC management.
- 2.2 The lease shall be for the two consecutive years. The lease rent shall be quoted on monthly basis for first twelve months i.e. first year and subsequent twelve months i.e. second year.
- 2.3 The two wheelers will include side car attached to scooter/ scooty but does not include tricycle rickshaw or three wheeler auto and these will be clubbed with 4-wheeler.
- 2.4 The parking facility shall be available to the visitors one hour before opening of the garden and till one hour after closing of the garden. However, for daily morning walkers, the car parking will be allowed up to 7.30a.m. free of cost at their own risk and responsibility. Morning walkers are issued the walking pass for their identity.

- 2.5 The safety, security and collection of fee from the visitors shall be the sole responsibility of the lessee.
- 2.6 The lessee has to ensure safe disposal of the waste materials, including oil spilled over from the two wheelers, if, any, after every day's transaction and clean the area, failing which he will be liable for penalty @Rs.250/- on each occasion. In this regard, decision of the Authority shall be final.
- 2.7 Any damage caused to the civil structures, grills and plants, either by the visitors or any other person/ persons shall have to be compensated by the lessee.
- 2.8 Disposal of unclaimed vehicles will be the responsibility of the lessee. The lessee has to report the same to the local police under intimation to the Administrative Officer of RPRC, Bhubaneswar.
- 2.9 The lessee has to deposit 10% (ten percent) of the total lease value of both the years combined as security deposit at the time of entering into an agreement. The above amount will be refunded on completion of the lease period after recovery, if any, and cannot be adjusted towards payment of lease amount.
- 2.10 The applicant has to deposit refundable EMD amount of Rs.2000/-(Two thousand only) in shape of bank draft drawn in favor of the Chief Executive, Regional Plant Resource Centre payable at Bhubaneswar along with the tender application which will be refunded to unsuccessful renderers, after the tendering process is over.
- 2.11 The applicant will also deposit another bank draft in the name of Regional Plant Resource Centre, Bhubaneswar payable at Bhubaneswar for Rs. 210/- ( 200+5% VAT) towards cost of tender paper along with the tender application, where the application has been downloaded.  
It may be noted that if the above two drafts are not enclosed; the tender application will be rejected.

### 3. Submission of tenders:

Tenders may be submitted in the prescribed format with all required information by the applicant on all working days till 26<sup>th</sup> December, 2016 (4.00P.M.). The tenders may be sent to the Chief Executive, Regional Plant Resource Centre, Nayapalli, Bhubaneswar 751015 by REGISTERED POST/ SPEED POST only.

The sealed tender should be super scribed as “Tender for Parking Space”. No tender will be received by hand or any other mode. Tenders reached after the stipulated date and time will not be entertained.

**4. Opening of tenders:**

The tenders will be opened at 5PM, on 26<sup>th</sup> December, 2016 in the presence of the tenderers or their authorized representatives, who are present at the time.

**5. Selection of lessee:**

The tender will be finalized on the basis of credentials and offer of rent. If felt necessary, the tenderers will be invited to make a presentation before a panel of selectors on a suitable date. Only highest offer of rent shall not entitle a tenderer for selection, however, this will be major consideration.

**6. Others:**

On finalization, the lessee has to pay the monthly rent before 7<sup>th</sup> day of the subsequent month.

The undersigned has the right to accept or reject any or all tenderes without assessing any reason thereof.
