- 5) RPRC shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.

- 6) The detailed specification and tentative quantity of Sign Boards to be prepared and installed are given in **Annexure "A"**. RPRC reserves the right to increase or decrease the quantity of work at the same rates and terms& conditions of contract.
- 7) Write up and photographs etc which are to be put on boards shall be obtained from RPRC and the dummy of the board should be approved after designing by the RPRC before final production.
- 8) Each page of the tender documents must be duly signed and stamped by the tenderer as a token of acceptance of all the terms &conditions of the tender.
- 9) Prices must be quoted strictly as per financial bid format given at **Annexure** "A" in this tender document and prices shall be firm and no escalation on account of labour or material or any other reason what so ever, will be paid to contractor for execution of the above work.

- 15) Company profile indicating list of clients of similar or releted nature shall be submitted by the tenderer.

- 17) The details of drawing, design and required sizes of Sign Board are enclosed with tender document.
- 18) If the selected firm does not complete the assigned job within **30 days** from issue of work order, the EMD money will be forfeited and the order shall automatically stand
